AAUW to train 10 million women to negotiate salaries by 2022 through Work Smart program

"It's Negotiable: A Salary Skill Builder" is an online preview of full online version of Work Smart- due out this year

Women's Policy Research shows that US economy would produce additional \$512 billion in income if women received equal pay

McKinsey study showed \$12 trillion could be added to global GDP by 2025 with stronger gender equity practices in workplace

Plan advocated by AAUW to close gender pay gap includes 3 points

Need strong federal and state pay equity laws

Updates needed to Equal Pay Act of 1964 and Title VII of the Civil Rights Act 39 states and Washington, D.C. considered pay legislation in 2018

Change employer practices and break down barriers for women

Examples: conduct pay audits within companies and ban use of prior salary histories to determine salary

Support women in advocating for selves

Leaders in Boston, Washington, D.C., Tempe, San Francisco, Long Beach and Common-wealth of Massachusetts have collaborative initiatives with AAUW to use Work Smart in their areas to train women

Update on Rizo v Fresno County Office of Education

US Court of Appeals for Ninth Circuit reversed decision of lower court- stated that prior salary alone cannot justify a pay differential

Decision affects employers in this court's jurisdiction

Paycheck Fairness Act that is pending in Congress would ban use of salary history nationwide and provide updates to strengthen the Equal Pay Act of 1963

AAUW signs onto 3 new Amicus Briefs

Horton v Midwest Geriatric Management (MGM), LLC

Case to be heard by US Court of Appeals for Eighth Circuit

Case will determine if employers that discriminate against lesbian, gay and bisexual employees are in violation of Title VII's prohibition against discrimination "because of sex"

Horton is a gay man who received job offer from MGM, but offer was revoked after learning that he is gay

Lampley v Missouri Commission on Human Rights

Case to be heard by Missouri Supreme Court

Case is like Horton case

Lampley is a gay man who alleges that his employer discriminated against him because his behavior and appearance contradicted male sex stereotypes

Jock v Sterling Jewelers

Class action lawsuit to be heard by US Court of Appeals for Second Circuit Class consists of women who are current or former employees of Sterling Jewelers Although case is about an arbitration agreement on "opting in" to agreement the underlying claims of the class of women challenges sex discrimination in pay and promotion opportunities under Title VII and the Equal Pay Act Arbitration agreement was included in class members' employment contracts Arbitration agreements are becoming more common within employment contracts and thus, make it more difficult to go court

The Snow Child by **Eowyn Ivey** will be discussed on Friday, May 18, at the Palm Springs Library. Donna Artes will moderate the discussion beginning at 2 pm.

"Alaska, 1920: a brutal place to homestead, and especially tough for recent arrivals Jack and Mabel. Childless, they are drifting apart—he breaking under the weight of the work of the farm; she crumbling from loneliness and despair. In a moment of levity during the season's first snowfall, they build a child out of snow. The next morning the snow child is gone—but they glimpse a young, blonde-haired girl running through the trees.

This little girl, who calls herself Faina, seems to be a child of the woods. She hunts with a red fox at her side, skims lightly across the snow, and somehow survives alone in the Alaskan wilderness. As Jack and Mabel struggle to understand this child who could have stepped from the pages of a fairy tale, they come to love her as their own daughter. But in this beautiful, violent place, things are rarely as they appear, and what they eventually learn about Faina will transform all of them."

At the May meeting, Jackie Winchester will present three titles for the selection of the June book. Mary Swieskowski will present titles in June for the July book.

Don't miss deadlines for state, national bylaws votes

As a branch member, you're also a member of both the state and national AAUW organizations and have a say in their operations and activities. Both organizations are proposing changes that you can weigh in on. And both use the email and postal addresses recorded in national's Membership Services Database to contact you about voting. It's a good idea to check your profile at www.aauw.org/login to make sure it's correct. Information on issues and deadlines for each ballot follows.

National Vote on dropping degree requirement ends June 9

The national board of directors is proposing three changes to the bylaws that they believe are needed to make AAUW more effective:

- 1. Should AAUW membership be open to those who don't have a degree but who support the organization's mission?
- 2. Should the national board of directors include those who are not members of AAUW?
- 3, Should three-year staggered terms be created for service on the national board of directors?

Voting opened April 25 and will close June 9 at 9 p.m. ET.
You're encouraged to vote online using your member ID and Pin which was emailed to you. Voting results will be announced online June 10.

The board sent an email explanation to all members – www.aauw.org/resource/nationalelection/.

It also provided its rationale along with the exact wording of the bylaws' changes at https://svc.aauw.org/recore/docu/aauw-bylaws-2017.pdf.

The two proposals about board service are seen as best practices bringing AAUW in line with other nonprofits.

The more wide-reaching proposal to drop the degree requirement has come up for a vote before and did not pass. So members must again decide on what would be a major shift in AAUW.

The board believes dropping the degree requirement would align better with our mission; bring in more members; increase our impact; enhance diversity; and make it easier to get grants. •

State public policies' vote starts May 15, ends June 15

The AAUW Florida board is asking for approval of two proposals:

1. Public policy priorities.

Florida's public policy priorities are due for approval this year, and, again, you're asked to adopt the public policy priorities that national has identified to inform advocacy efforts for the next two years.

You can get details on the national priorities at https://www.aauw.org/resource/principles-and-priorities.

2.Pay equity resolution. You're also asked to approve the sending of an official thanks to legislator Lori Berman and her assistant Abby Ross for work on legislation aimed at pay equity for women.

Dates, deadlines. You're eligible to vote if you've been a member of AAUW Florida as of March 15, 2018.

You'll get instructions and ballots by Email based on your contact information in Member Services Database. If you don't have email, you'll receive a paper ballot.

Online voting begins May 15 and ends June 15 at 9 p.m. EDT.

Paper ballots must be postmarked by 11:59 p.m., EDT, June 13

Voting results will be announced in an email to branch presidents and on our state website.
